A RESOLUTION LEVYING A SPECIAL ASSESSMENT TAX UPON ALL BENEFITED PROPERTY IN A SPECIAL IMPROVEMENT DISTRICT OR PROJECT KNOWN AS 1380, IN THE CITY OF BILLINGS, MONTANA.

SECTION 2: <u>DISPOSITION OF COLLECTION</u>. All monies collected from the assessment shall be paid into a special improvement district or project Fund. Assessments become delinquent based on the semi-annual due dates of real property taxes, currently December 1 and June 1 of each year.

SECTION 3: <u>NOTICE AND HEARING</u>. On Monday, September 22, at 6:30 p.m., or as soon thereafter as the matter was considered on the agenda of the City Council at a regular meeting held in the Council chambers of the Police facility, 220 N. 27th St., Billings, Montana, the City Council held a public hearing to hear comments and/or objections to the adoption of this resolution. The City Clerk published notice of the public hearing twice, with at least six (6) days separating each publication, in a newspaper of general paid circulation with a periodicals mailing permit. The final publication was made at least 10 days prior to the public hearing per MCA 7-12-4177. Council voted to continue the public hearing on the October 14, 2008 meeting.

SECTION 4: EFFECTIVE DATE. This resolution shall be effective immediately upon approval.
