

## CALL FOR SEALED BIDS: NOTICE TO BIDDERS

Sealed bids entitled Main Entry Sign Billings Logan International Airport, Billings, Montana, will be received addressed to the City Clerk, of the City of Billings, 220 North 27th Street, Billings, Montana 59101, or P.O. Box 1178, Billings, Montana 59103 until 2:00 p.m. on Tuesday, March 9, 2010.

There will be a Prebid Conference in the Russ Lehner Conference Room 219, Billings Logan International Airport, at 10:00 a.m., Thursday, March 4, 2010. Failure of the **CONTRACTOR** to thoroughly familiarize themselves with the scope of this project does not relieve the **CONTRACTOR** from the requirements of this Agreement.

All laborers and mechanics employed by contractors or subcontractors in performance of this Contract will be paid wages at rates as may be required by the laws of the *CITY OF BILLINGS* and the State of Montana. The **CONTRACTOR** must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex or national origin.

Each bid or proposal must be accompanied by a Certified Check, Cashier's Check, or Bid Bond payable to the *CITY OF BILLINGS*, Montana, in an amount not less than ten percent (10%) of the total amount of the bid. The bid bond will be retained by the City Clerk until the successful bidder enters into a Contract with the *CITY OF BILLINGS*. If no Contract is entered into, by the successful bidder, within thirty (30) days, the bond will be forfeited to the *CITY OF BILLINGS*. Bid bonds will be returned to the unsuccessful bidders immediately after final action on the bid, by the City Council.
