

REGULAR MEETING OF THE BILLINGS CITY COUNCIL

October 9, 2018

The Billings City Council met in regular session in the Council Chambers located on the second floor of the Police Facility, 220 North 27th Street, Billings, Montana. Mayor Cole called the meeting to order at 5:30 p.m. and served as the meeting's presiding officer. Councilmember Ronning gave the invocation.

ROLL CALL: Councilmembers present on roll call were: Yakawich, Brewster, Ewalt, Joy, Friedel, Gibbs, Ronning, and Clark. Councilmembers Cromley and Brown were excused.

MINUTES: September 24, 2018 - Councilmember Brewster moved for approval, seconded by Councilmember Ewalt. On a voice vote, the motion was unanimously approved.

COURTESIES:

- Mayor Cole recognized Boy Scout Troop #8 and asked them and their leaders to approach the podium for introductions.

PROCLAMATIONS:

- Mayor Cole pronounced the month of October as National Chiropractic Health Month. He reminded citizens that chiropractic treatment may be a healthy option for pain management.
- Mayor Cole pronounced the month of October as National Code Compliance Month. He recognized local code enforcement officers, building officials, plan reviewers and building inspectors for their dedication to improving life safety and neighborhood aesthetics in Billings.
- Mayor Cole pronounced October 15, 2018 as White Cane Awareness Day, and stated the white cane demonstrated and symbolized the ability for blind citizens to achieve full and independent lives. He encouraged motorists and cyclists to be aware and exercise appropriate caution when approaching a blind person carrying a white cane.
- Mayor Cole pronounced October 16, 2018 as Pink Day to raise awareness of breast cancer and presented Susy Paddock and Tracy Kangas with the proclamation. They thanked the Mayor and Council and provided t-shirts to them. Ms. Paddock and Ms. Kangas stated that since the "Pack the Place in Pink" campaign started 12 years ago, the non-profit organization had raised over \$350,000 to provide financial assistance to over 347 breast cancer patients.

ADMINISTRATOR REPORTS - BRUCE MCCANDLESS

- Mr. McCandless reminded Council that a Special Meeting would be held on Wednesday, October 10, 2018, at 5:30 P.M., in the Council Chambers, to discuss the City Administrator finalist interviews.
- Concerning Item 1E, Mr. McCandless explained that the changes that had been proposed by Bresnan mostly favored them. He stated that a one-year extension gave City staff more time to negotiate an agreement that may be more beneficial to the City.
- Mr. McCandless stated there were no ex-parte communications received concerning items on the agenda.

Councilmember Ronning, in reference to Item 1E, voiced her disappointment with Bresnan's quality of broadband service and experiencing tiling while viewing programming. She encouraged City staff to negotiate for better service.

On a voice vote, the Consent Agenda with the exception of 1F, were unanimously approved.

Councilmember Yakawich moved for approval of Item 1F, seconded by Councilmember Joy. On a voice vote, the motion was approved 7-2, Councilmembers Friedel and Ronning voted in opposition.
