

RESOLUTION NO. 98-17371

A RESOLUTION LEVYING AND ASSESSING A TAX UPON ALL PROPERTY IN ALLEY APPROACH WORK ORDER NO. 97-02#02 (ASSESSMENT # 9897), IN THE CITY OF BILLINGS, MONTANA, FOR THE PURPOSE OF LEVYING AND ASSESSING THE COST AND EXPENSE OF MAKING IMPROVEMENTS THEREIN. 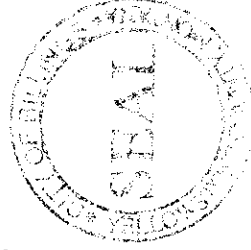
