

RESOLUTION NO. 97- 17195

A RESOLUTION PURSUANT TO BILLINGS, MONTANA CITY CODE ARTICLE 22-700, RENAMING THE STREET OF CRESTWOOD DRIVE (BETWEEN CENTRAL AVENUE AND COOK AVENUE) TO NORTH CRESTWOOD DRIVE.

WHEREAS, the City Council has authority to change the name of any street or avenue pursuant to Section 22-700, Billings, Montana City Code (BMCC); and

WHEREAS, the City Clerk published a notice of the public hearing in accordance with Section 22-702, Billings, Montana City Code (BMCC); and

WHEREAS, the City Clerk mailed a notice of the public hearing to each property owner, or his agent on **Crestwood Drive (between Central Avenue and Cook Avenue)** in accordance with Section 22-702, Billings, Montana City Code (BMCC); and

WHEREAS, on Monday, **February 10, 1997** the City Council held a public hearing on the renaming of **Crestwood Drive (between Central Avenue and Cook Avenue)**; and

WHEREAS, the City Council of Billings finds that the renaming of **Crestwood Drive (between Central Avenue and Cook Avenue)** is in the best interests of the City and the inhabitants thereof.

NOW, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA:

That once a copy of this resolution is filed with the Yellowstone County Clerk and Recorder, the street of **Crestwood Drive (between Central Avenue and Cook Avenue)** is deemed changed to **NORTH CRESTWOOD DRIVE**.

PASSED by the City Council and APPROVED this 10th. day of February, 1997.

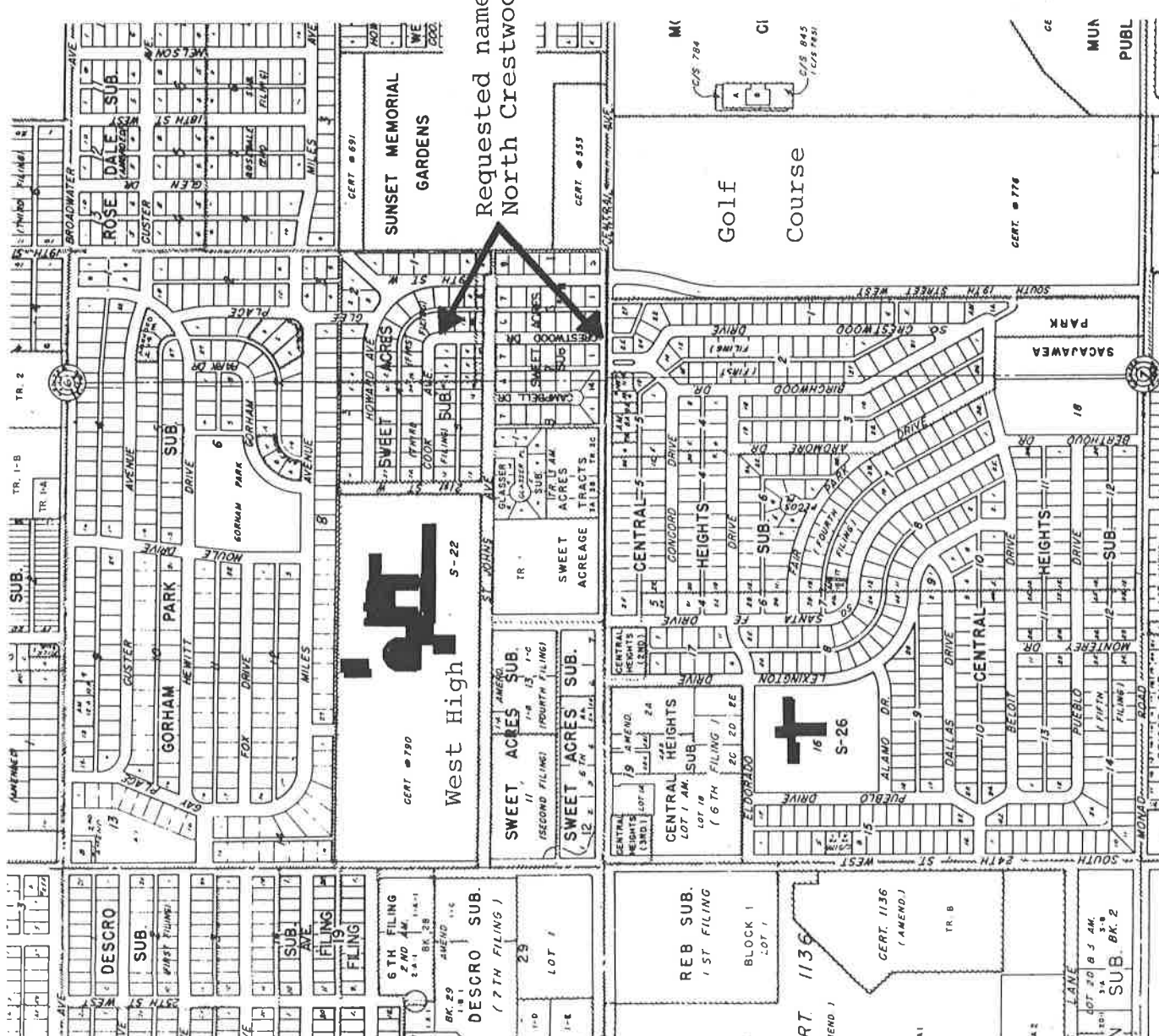

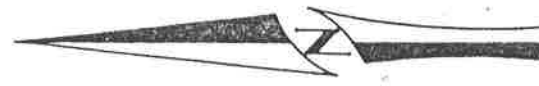
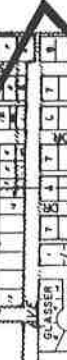
