

RESOLUTION NO. **03-18045**

A RESOLUTION OF THE CITY OF BILLINGS,
MONTANA, DISCONTINUING AND VACATING **portions
of cul-de-sac rights-of-way within Rehberg Ranch
Estates Subdivision, First Filing.**

WHEREAS, a proper petition was filed with the City Council of the City of Billings, Montana, as per Section 22-601 BMCC, requesting discontinuance and vacation of **portions of cul-de-sac rights-of-way within Rehberg Ranch Estates Subdivision, First Filing** as described hereinafter; and

WHEREAS, a public hearing was properly noticed and held as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA, AS FOLLOWS:

1. **DISCONTINUANCE AND VACATION.** Pursuant to Sections 7-14-4114 and 7-14-4115, M.C.A., **portions of cul-de-sac rights-of-way along Smohawk Trail, Cabin Creek Trail, and Shotgun Trail all within Rehberg Ranch Estates Subdivision, First Filing** generally described as follows, are hereby discontinued, abandoned and vacated:

A. Portions of Smohawk Trail more particularly described as follows:

- i. Beginning at the southeasterly corner of Lot 12, Block 6, Rehberg Ranch Estates Subdivision, First Filing recorded on July 10, 2002 under Document #3183382, records of Yellowstone County, State of Montana; thence S 32° 46' 52" W for a distance of 60.27 feet to the True Point of Beginning; thence S 32° 46' 52" W for a distance of 20.75 feet to the beginning of a curve; thence along a curve to the right with a radius of 19.00 feet a length of 24.27 feet (chord bearing S 69° 22' 04" W a distance of 22.65 feet) to a point; thence N 74° 02' 44" W for a distance of 10.11 feet to a point on the southeasterly line of Lot 10, Block 6 of said Subdivision, also being the beginning of a non-tangent curve; thence along said non-tangent curve to the right with a radius of 45.00 feet a length of 31.34 feet (chord bearing N 63° 43' 24" E a distance of 30.71 feet) to the beginning of a reverse curve; thence along said reverse curve to the left with a radius of 20.00 feet a length of 17.77 feet (chord bearing N 58° 13' 39" E a distance of 17.19 feet) to the True Point of Beginning; Containing 374 square feet more or less as shown as PUBLIC RIGHT-OF-WAY VACATION #1 on Exhibit "A" attached.

- ii. Beginning at the westerly corner of Lot 14, Block 6, Rehberg Ranch Estates Subdivision, First Filing recorded July 10, 2002 under Document #3183382 records of Yellowstone County, State of Montana; thence S 32° 46' 52" W a distance of 27.85 feet to the True Point of Beginning, also being the beginning of a curve; thence along said curve to the left with a radius of 20.00 feet a length of 17.77 feet (chord bearing S 07° 20' 04" W a distance of 17.19 feet) to a point on the westerly line of Lot 13, Block 6 of said Subdivision, also being the beginning of a reverse curve; thence along said reverse curve to the right with a radius of 45.00 feet a length of 88.81 feet (chord bearing S 38°25'31" W a distance of 75.08 feet) to a point on the northerly line of Lot 8, Block 6 of said Subdivision; thence N 32° 46' 52" E a distance of 90.24 feet to the True Point of Beginning; Containing 1,377 square feet more or less as shown as PUBLIC RIGHT-OF-WAY VACATION #2 on Exhibit "A" attached.
- iii. Beginning at the southwesterly corner of Lot 20, Block 5, Rehberg Ranch Estates Subdivision, First Filing recorded July 10, 2002 under Document #3183382 records of Yellowstone County, State of Montana; thence S 50° 57' 16" W a distance of 46.85 feet to the True Point of Beginning; thence S 50° 57' 16" W a distance of 34.50 feet to the beginning of a curve; thence along said curve to the left with a radius of 321.00 feet a length of 34.08 feet (chord bearing S 47° 54' 47" W a distance of 34.06 feet) to a point; thence S 44° 52' 18" W a distance of 23.86 feet to a point on the easterly line of Lot 18, Block 5 of said Subdivision, also being the beginning of a non-tangent curve; thence along said non-tangent curve to the right with a radius of 45.00 feet a length of 93.59 feet (chord bearing N 42° 16' 07" E a distance of 77.61 feet) to the beginning of a reverse curve; thence along said reverse curve to the left with a radius of 20.00 feet a length of 17.77 feet (chord bearing N 76° 24' 04" E a distance of 17.19 feet to the True Point of Beginning; Containing 1,467 square feet more or less as shown as PUBLIC RIGHT-OF-WAY VACATION #1 on Exhibit "B" attached.
- iv. Beginning at the northwesterly corner of Lot 15, Block 5, Rehberg Ranch Estates Subdivision, First Filing recorded July 10, 2002 under Document #3183382 records of Yellowstone County, State of Montana, also being the beginning of a curve; thence along said curve to the left with a radius of 129.00 feet a length of 20.63 feet (chord bearing S 71° 11' 01" W a distance of 20.60 feet) to a point on the northwesterly line of Lot 16, Block 5 of said Subdivision; thence S 50° 57' 16" W a distance of 46.85 feet to a point on the northwesterly line of said Lot 16, also being the beginning of a curve and the True Point of Beginning; thence along said curve to the left with a radius of 20.00 feet a length of 17.77 feet

(chord bearing S 25° 30' 28" W a distance of 17.19 feet) to a point on the northwesterly line of said Lot 16, also being the beginning of a reverse curve; thence along said reverse curve to the right with a radius of 45.00 feet a length of 14.58 feet (chord bearing S 09° 20' 26" W a distance of 14.51 feet) to a point on the northwesterly line of said Lot 16; thence N 24° 12' 50" W a distance of 2.99 feet to the beginning of a curve; thence along said curve to the right with a radius of 19.00 feet a length of 24.93 feet (chord bearing N 13° 22' 13" E a distance of 23.18 feet) to a point; thence N 50° 57' 16" E a distance of 7.24 feet to the True Point of Beginning; Containing 94 square feet more or less as shown as PUBLIC RIGHT-OF-WAY VACATION #2 on Exhibit "B" attached.

- v. Beginning at the northwesterly corner of Lot 15, Block 5, Rehberg Ranch Estates Subdivision, First Filing recorded July 10, 2002 under Document #3183382 records of Yellowstone County, State of Montana, also being the beginning of a curve; thence along said curve to the left with a radius of 129.00 feet a length of 20.63 feet (chord bearing S 71° 11' 01" W a distance of 20.60 feet) to a point on the northwesterly line of Lot 16, Block 5 of said Subdivision; thence S 50° 57' 16" W a distance of 46.85 feet to a point on the northwesterly line of said Lot 16, also being the beginning of a curve; thence along said curve to the left with a radius of 20.00 feet a length of 17.77 feet (chord bearing S 25° 30' 28" W a distance of 17.19 feet) to a point on the northwesterly line of said Lot 16, also being the beginning of a reverse curve; thence along said reverse curve to the right with a radius of 45.00 feet a length of 51.62 feet (chord bearing S 32° 55' 26" W a distance of 48.84 feet) to the northwest lot corner of said Lot 16, said corner also common to Lot 17, Block 5 of said Subdivision; thence continuing on a curve to the right with a radius of 45.00 feet a length of 12.06 feet (chord bearing S 73° 27' 49" W a distance of 12.02 feet) to the True Point of Beginning on the northerly line of said Lot 17, also being the beginning of a curve; thence along said curve to the right with a radius of 45.00 feet a length of 18.14 feet (chord bearing N 86° 35' 51" W a distance 18.02 feet) to a point on the northerly line of said Lot 17, also being the beginning of a non-tangent curve; thence along said non-tangent curve to the right with a radius of 19.00 feet a length of 18.78 feet (chord bearing S 86° 35' 51" E a distance of 18.02 feet to the True Point of Beginning; Containing 39 square feet more or less as shown as PUBLIC RIGHT-OF-WAY VACATION #3 on Exhibit "B" attached.

B. Portions of Cabin Creek Trail more particularly described as follows:

- i. Beginning at the northerly corner of Lot 24, Block 5, Rehberg Ranch Estates Subdivision, First Filing recorded July 10, 2002 under Document #3183382 records of Yellowstone County, State of Montana, said corner also common to Lot 25, Block 5 of said Subdivision and being the beginning of a curve; thence along said curve to the right with a radius of 45.00 feet a length of 21.85 feet (chord bearing N 25° 08' 11" W a distance of 21.63 feet) to the True Point of Beginning; thence continuing along a curve to the right with a radius of 45.00 feet a length of 66.23 feet (chord bearing N 30° 56' 12" E a distance of 60.41 feet) to a point on the southeasterly line of Lot 25, Block 5 of said Subdivision; thence S 34° 16' 00" E a distance of 3.27 feet to the beginning of a curve; thence along said curve to the right with a radius of 19.00 feet a length of 28.26 feet (chord bearing S 08° 20' 38" W a distance of 25.73 feet) to a point; thence S 50° 57' 16" W a distance of 37.56 feet to the True Point of Beginning; Containing 988 square feet more or less as shown as PUBLIC RIGHT-OF-WAY VACATION #1 on Exhibit "C" attached.
 - ii. Beginning at the northwesterly corner of Lot 22, Block 5, Rehberg Ranch Estates Subdivision, First Filing recorded July 10, 2002 under Document #3183382 records of Yellowstone County, State of Montana, also being the beginning of a curve; thence along said curve to the left with a radius of 129.00 feet a length of 25.69 feet (chord bearing S 56° 39' 37" W a distance of 25.65 feet); thence S 50° 57' 16" W a distance of 46.68 feet to a point on the northwesterly line of Lot 23, Block 5 of said Subdivision, also being the beginning of a curve and the True Point of Beginning; thence along said curve to the left with a radius of 20.00 feet a length of 17.77 feet (chord bearing S 25° 30' 29" W a distance of 17.19 feet) to a point on the northwesterly line of said Lot 23, also being the beginning of a reverse curve; thence along said reverse curve to the right with a radius of 45.00 feet a length of 88.81 feet (chord bearing S 56° 35' 56" W a distance of 75.08 feet) to a point on the northerly line of Lot 24, Block 5 of said Subdivision; thence N 50° 57' 16" E a distance of 90.24 feet to the True Point of Beginning; Containing 1,377 square feet more or less as shown as PUBLIC RIGHT-OF-WAY VACATION #2 on Exhibit "C" attached.
- C. Portions of Shotgun Trail more particularly described as follows:
- i. Beginning at the northerly corner of Lot 31, Block 5, Rehberg Ranch Estates Subdivision, First Filing recorded July 10, 2002 under Document #3183382 records of Yellowstone County, State of Montana, said corner also common to Lot 32, Block 5 of said Subdivision and being the beginning of a curve; thence

along said curve to the right with a radius of 45.00 feet a length of 21.85 feet (chord bearing N 14° 25' 02" W a distance of 21.63 feet) to a point on the southeasterly line of said Lot 32, also being the True Point of Beginning; thence continuing along a curve to the right with a radius of 45.00 feet a length of 43.51 feet (chord bearing N 27° 11' 34" E a distance of 41.84 feet) to a point on the southeasterly line of Lot 32, Block 5 of said Subdivision; thence S 20° 57' 26" E a distance of 7.18 feet to the beginning of a curve; thence along said curve to the right with a radius of 19.00 feet a length of 27.40 feet (chord bearing S 20° 21' 29" W a distance of 25.09 feet); thence S 61° 40' 25" W a distance of 14.72 feet to the True Point of Beginning; Containing 461 square feet more or less as shown as PUBLIC RIGHT-OF-WAY VACATION #1 on Exhibit "D" attached.

- ii. Beginning at the northwesterly corner of Lot 29, Block 5, Rehberg Ranch Estates Subdivision, First Filing recorded July 10, 2002 under Document #3183382 records of Yellowstone County, State of Montana, also being the beginning of a curve; thence along said curve to the left with a radius of 129.00 feet a length of 22.92 feet (chord bearing S 56° 03' 41" W a distance of 22.90 feet) to a point on the northwesterly line of Lot 30, Block 5 of said Subdivision; thence S 50° 57' 16" W a distance of 48.45 feet to a point on the northwesterly line of said Lot 30, also being the beginning of a curve and the True Point of Beginning; thence along said curve to the left with a radius of 20.00 feet a length of 17.77 feet (chord bearing S 25° 30' 28" W a distance of 17.19 feet) to a point on the northwesterly line of said Lot 30 to the beginning of a reverse curve; thence along said reverse curve to the right with a radius of 45.00 feet a length of 97.23 feet (chord bearing S 61° 57' 30" W a distance of 79.39 feet) to a point on the northerly line of Lot 31, Block 5 of said Subdivision; thence N 61° 40' 25" E a distance of 11.65 to a point, also being the beginning of a curve; Thence along said curve to the left with a radius of 321.00 feet a length 60.05 feet (chord bearing N 56° 18' 51" E a distance of 59.97 feet) to a point; thence N 50° 57' 16" E a distance of 22.29 feet to the True Point of Beginning; Containing 1,554 square feet more or less as shown as PUBLIC RIGHT-OF-WAY VACATION #2 on Exhibit "D" attached.

2. PUBLIC INTEREST. The discontinuance, vacation and abandonment of the above-described **portions of cul-de-sac rights-of-way within Rehberg Ranch Estates Subdivision, First Filing** is in the best interest of the public and can be done without any public detriment. Ownership of the vacated area will revert to the adjacent properties.

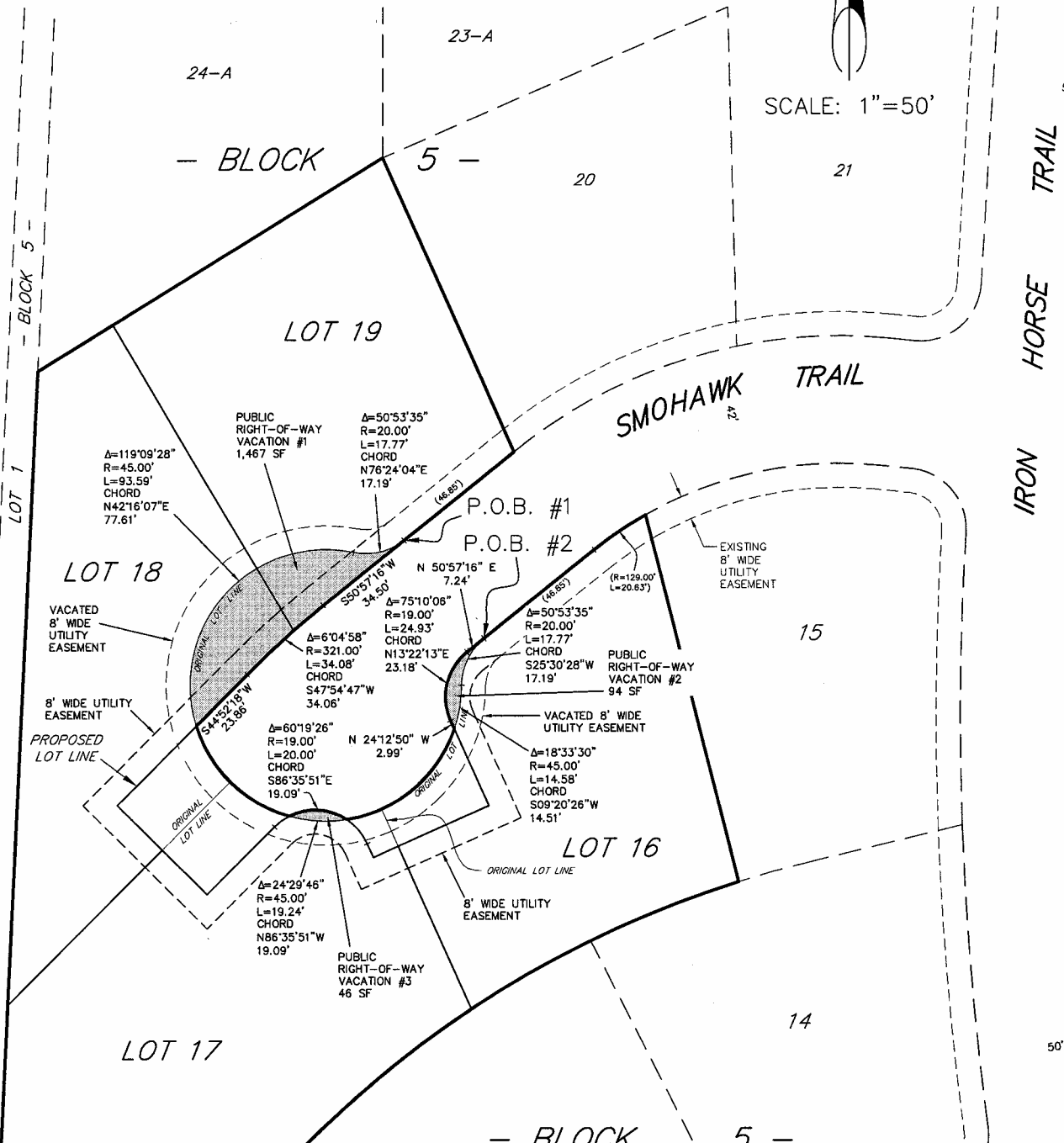

YELLOWSTONE COUNTY, MONTANA

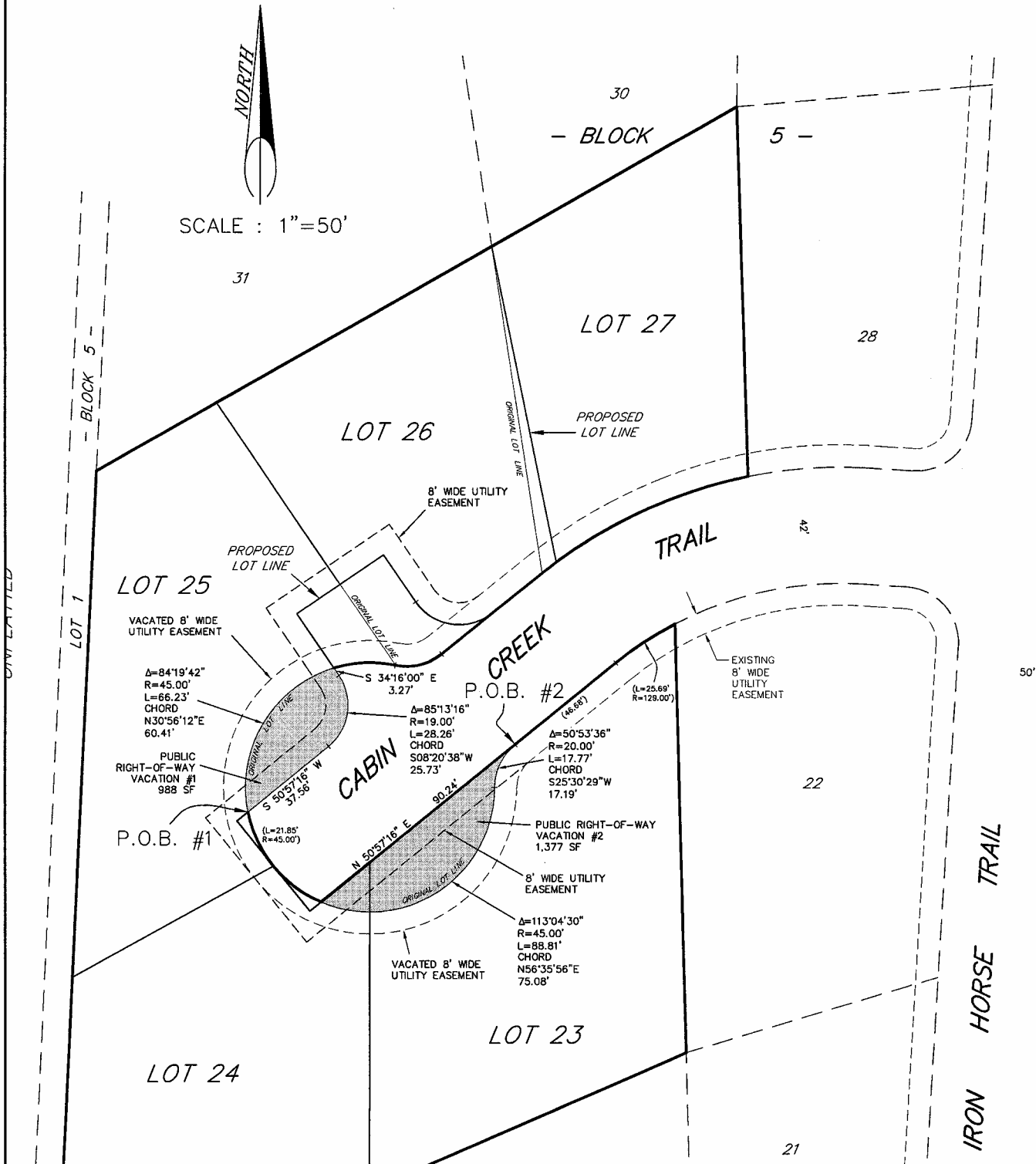
